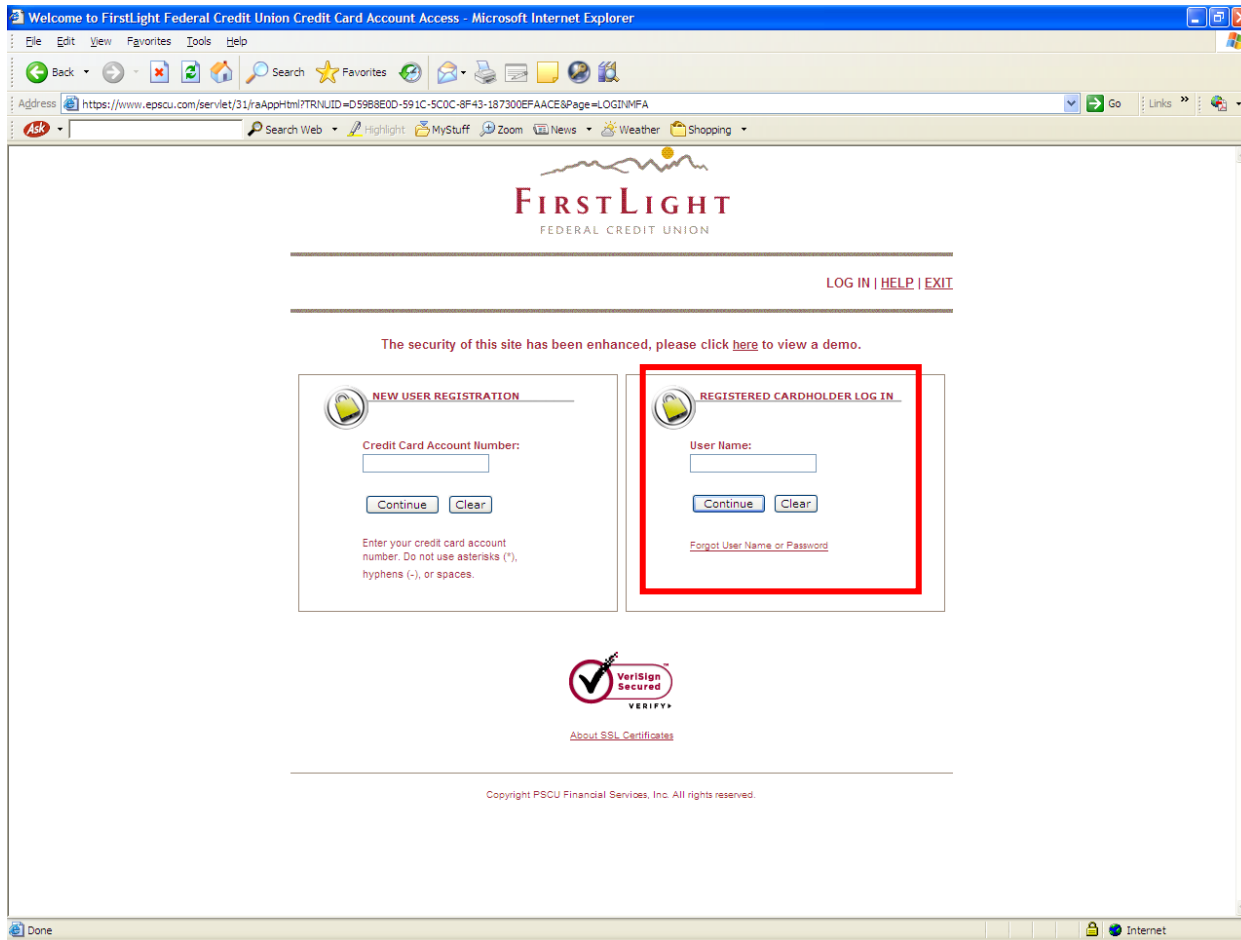

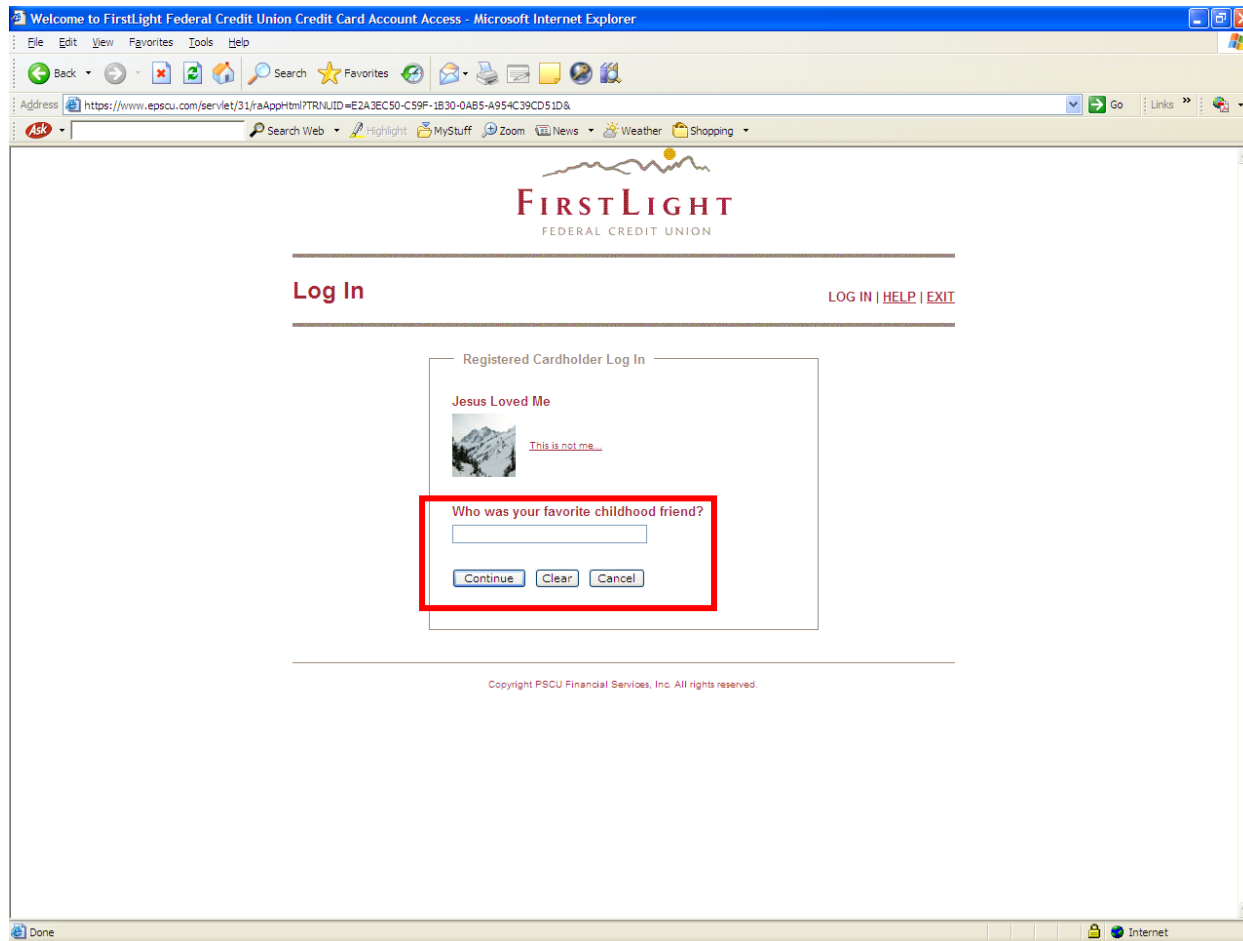

Signing In to Credit Card Accounts Online

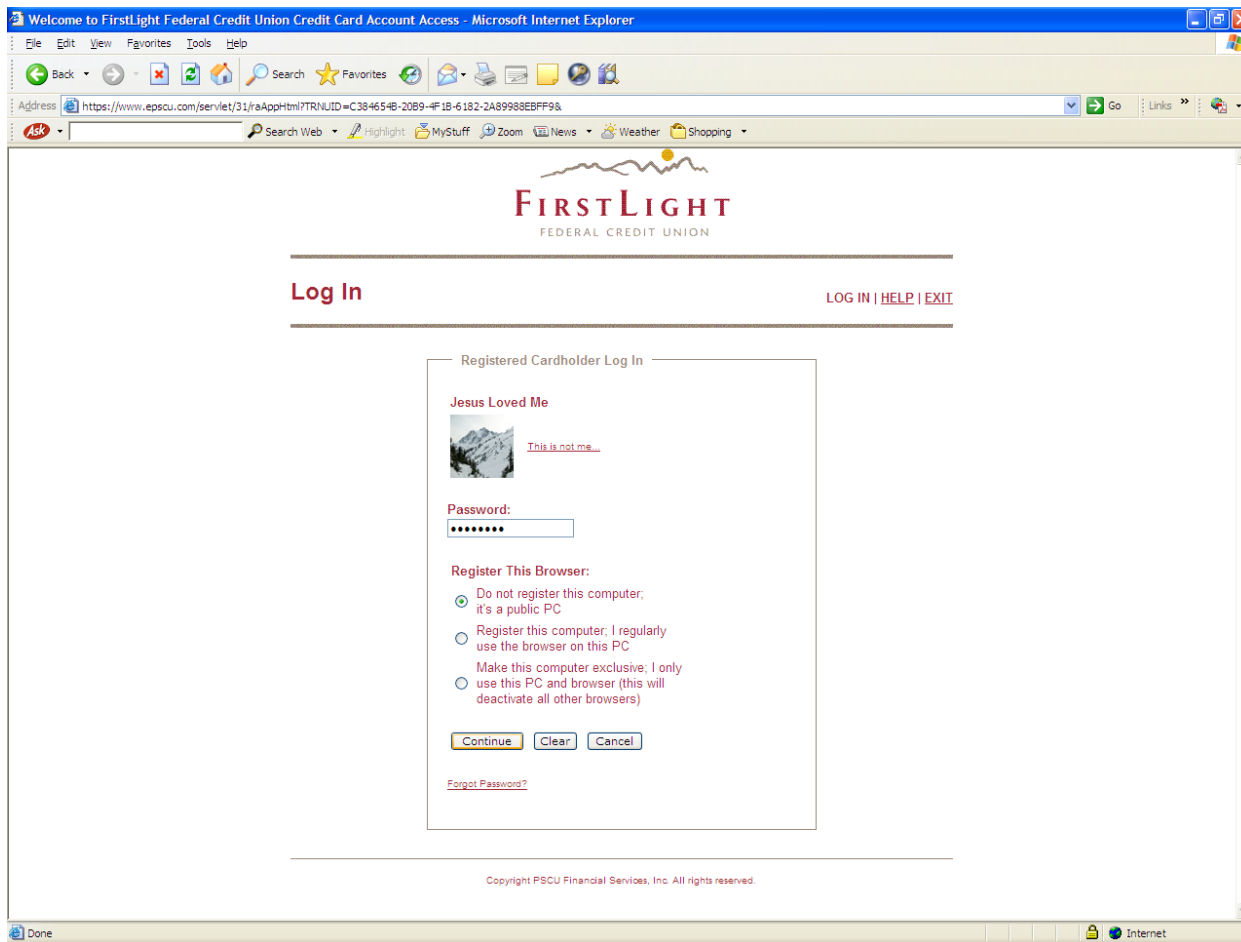
Type in your existing user name and click the *Continue* button.



Confirm that the pass phrase and picture are what you set up during the registration process. If so, type in the answer to the question and click the *Continue* button.



Enter your password and select one of the options under *Register This Browser*. Click the *Continue* button.



The existing card will appear on the screen. Under *Select Card*, the last four digits of the existing card will display.

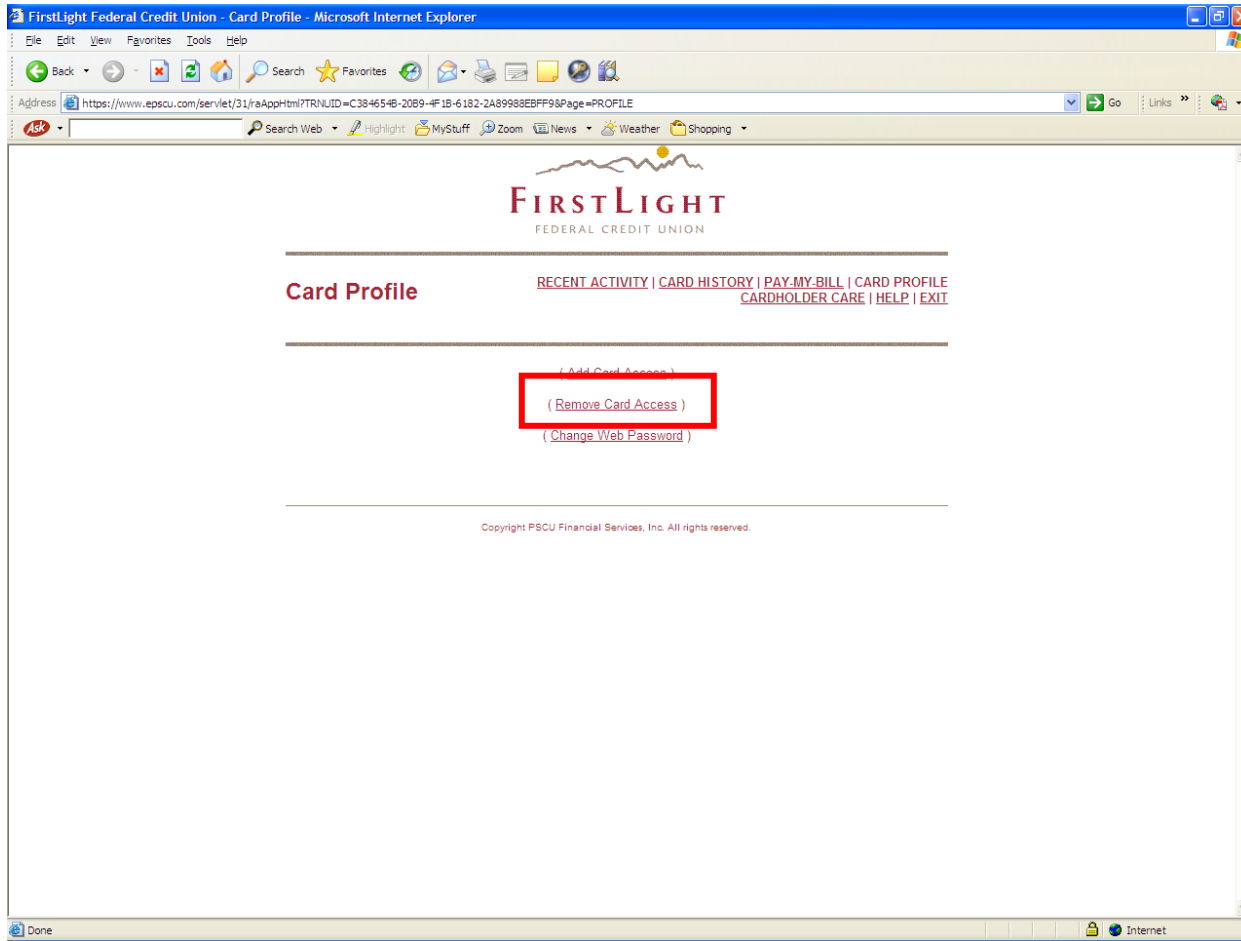

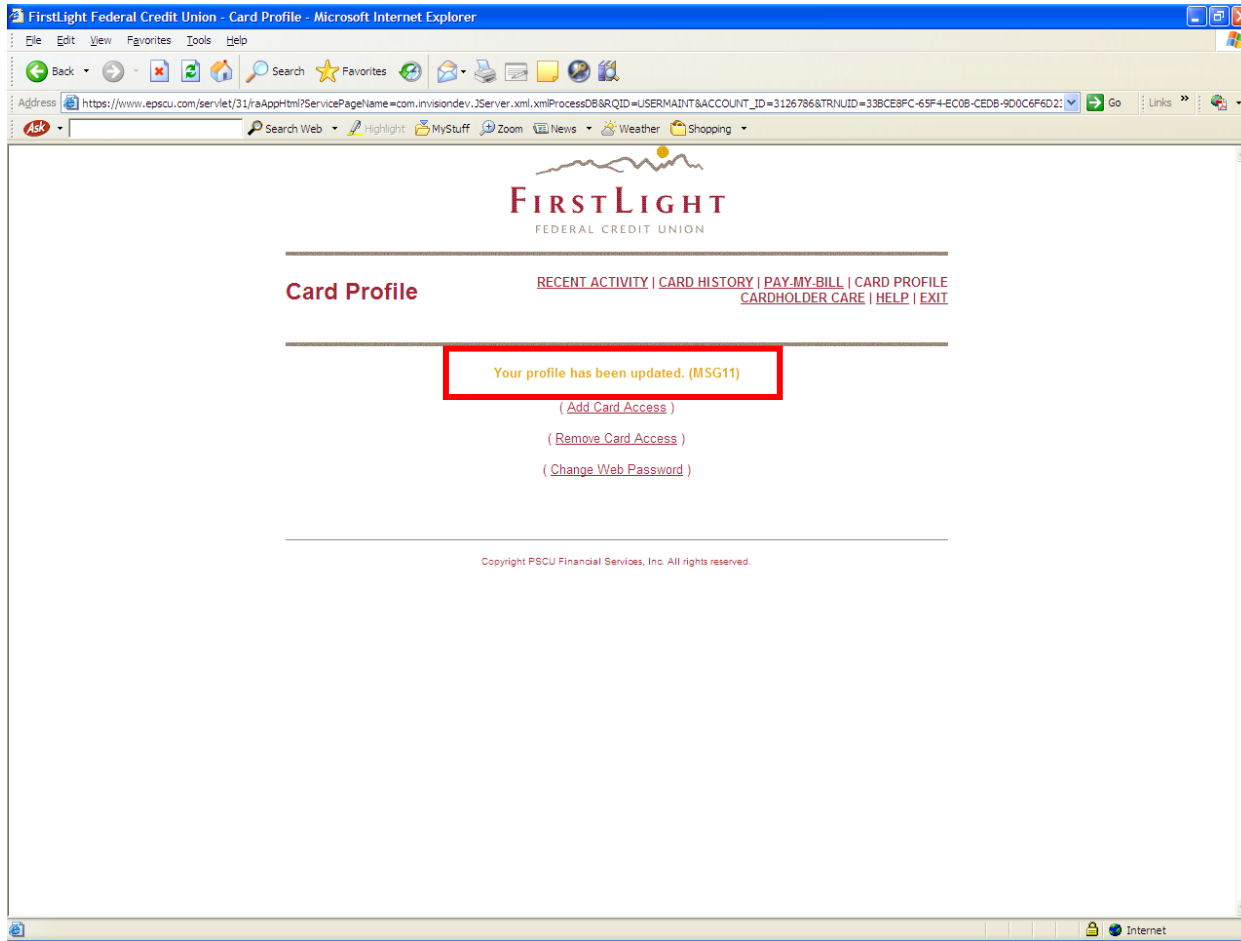
Select the card you would like to remove from the drop down list and click the *Continue* button.

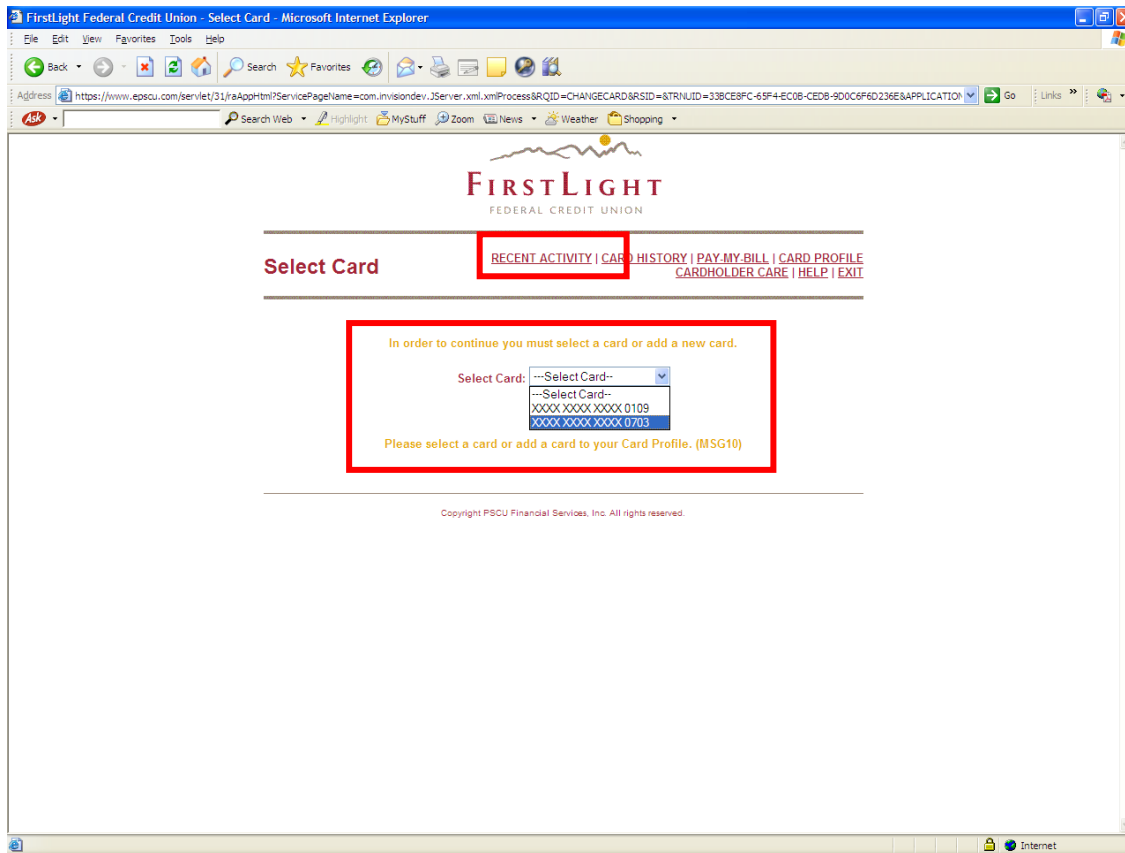


You should see a message stating "Your profile has been updated."




To return to the initial default screen, click on *Recent Activity*.
